Licensing Policy & Procedures for SIA Publications

Attachment: Publication Copyright License Request

The Society for International Affairs has copyrights on all of its publications. Any entity who desires to use any of these items for dissemination within their company/organization must request permission from SIA to license these items. Such dissemination could include, among other means, providing photocopies to its employees, incorporating the publication, poster or video on its intranet website or into an internal compliance manual or training tool.

There are two types of Licenses available – “Initial” and “Edition Update”. First time requests will only be eligible for the “Initial” license. The initial license is granted for a specified edition. If there is a desire to obtain updated copies of SIA publications under an existing license, a new written request must be submitted to SIA for an Edition Update license, as noted below, specifying the edition requested. Edition Update licenses are only available to entities who have been granted (and can provide a proof of) an Initial license.

All requests to license a SIA copyrighted publication must be made in writing, on the SIA Publication Copyright Request Form and sent to the SIA Vice President for approval.

- An initial assessment will be completed and the SIA Vice President will contact the Requestor regarding payment (to be made directly to the SIA Business Manager).
- Once payment is received and confirmed, the SIA Vice President will provide written approval to the Requestor, along with an electronic copy of the licensed publications, if appropriate, or will ask the Business Manager to provide the subject publications.
